We mobilize communities with timely bone health information to support strong and healthy bones and prevent osteoporosis and fractures. We build local community outreach through technical support, programs, and public awareness campaigns. We engage public advocates for osteoporosis prevention, detection, and treatment.

Community education: [1] New signature event: The Calcium Challenge. Surveyed customers at 4 ShopRite stores in PA, NJ, and MD, finding only 30% report getting their recommended amount of calcium in their diet. Retail dieticians played The Calcium Challenge card game with shoppers to teach them about the best sources of dietary calcium and how to make healthy choices. After playing the game, nearly 60% of shoppers thought they could get the calcium they needed from food. [2] Held 4th annual Freedom From Fractures screening event. 240 Peer Educators screened 777 people at 37 locations in 17 states and counseled them on how to reduce their chances of losing their independence and mobility because of a debilitating fracture. Ages 45-101 (average age 75); 55% of Medicare age participants had not had a bone density test. [3] The Best Bones Forever! Held Bone Health Clinic for Middle Schoolers at the Highland Recreation Center in San Mateo with over 80 kids! It was LOUD! It was FUN! The kids learned how important their bones are and took home a copy of "Act Now - A Parent's Guide to Bone Health." This interactive program communicated key messages about bone health nutrition and physical activity for boys and girls. [4] Held 2nd Annual Stepping Out Strong at various YMCAs across the country. Every 13 seconds, an older adult is seen in an emergency (Continued on Schedule O, Statement 1)

Public screening: Performed bone density testing and comprehensive reports for 1,329 patients, including 280 free tests for people who otherwise would not be able to receive one.

4c (Code:) (Expenses \$ 65,699 including grants of \$ 0) (Revenue \$ 115,316)

Professional education: [1] Certified 56 individuals to sit for their limited license in bone densitometry with the State of California Radiology Health Branch. The three-day lecture, lab, and clinical instruction course allowed us to provide free bone density tests for over 300 patients who would otherwise not have access to testing. [2] 7 physicians took our Radiology Supervisory Operator and Fluoroscopy prep courses.

Stepping Out Strong addresses this crisis by working with YMCAs and our Peer Educators to do balance screening and teach simple exercises to reduce the risk of falls. Results from 16 locations and 181 participants found that 41% were at risk of falling because of poor or fair balance. Only 26.5% of those participating were both confident in their balance and performed well. [5] 225 new Peer Educators joined the team.
