Community education: [1] The Calcium Challenge, an in-store bone health nutrition event for shoppers, was held at 65 ShopRite stores in PA, NJ, MD, and NY during National Dairy Month in June with the help of the American Dairy Council, Northwest, Lactaid, and Cabot Cheese Cooperative. [2] The 3rd annual Stepping Out Strong event was held at 18 locations and reached 488 older adults. The average age of the participants was 64, with the youngest 23 and the oldest 97. A balance assessment conducted by the Peer Educators found that 41% were at risk of falling because of poor or fair balance. The program included practice of and take home materials of exercises to build into daily routines. [3] The 5th annual Freedom From Fractures screening and awareness week was the most successful to date. Thanks to our staff and interns, and a special thanks to the hundreds of dedicated Peer Educators who participated and the locations who hosted the events. 246 Peer Educators screened 929 people at 41 locations in 20 states and counseled them on how to reduce their chances of breaking a bone. 70% of those screened were at moderate or high risk of breaking a bone in the next 10 years. 84% of the high risk participants are not taking a medication that can reduce their risk of fracture. 35% of women age 65+ and 66% of men age 70+ have not had a bone density test, a

4b (Code:) (Expenses \$ 52,825 including grants of \$ 0) (Revenue \$ 29,161)

Public screening: Performed bone density testing and comprehensive reports for 462 patients, including 213 free tests for people who otherwise would not be able to receive one. We ceased bone density testing during the year, due to insufficient reimbursements from insurance companies. After 27 years of providing this critical diagnostic test to East Bay patients, we transferred our equipment and records to Inview Imaging, a local radiology practice.

Professional education: [1] Certified 35 individuals to sit for their limited license in bone densitometry with the State of California Radiology Health Branch. The three-day lecture, lab, and clinical instruction course allowed us to provide free bone density tests for over 200 patients who would otherwise not have access to testing. [2] 8 physicians took our Radiology Supervisory Operator and Fluoroscopy prep courses.
